- II. Larkin Development Presentation Tim Larkin (also present: Sam Gregario and Bossier City Councilman David Montgomery)
  - A. Gregario Family Realty has decided to develop their 53.38 acre tract of land 4750 Modica Lott Road between Willow Chute and Racetrack Bayous (the land is on the north side of Modica Lott and backs up to Tiburon)
  - B. The subdivision will be named Provident Oaks and will be modeled after Oak Alley luxury living, small lawns, gated entry, etc.
  - C. There will be 160 approved homes, 60 X 150 ft. lot sizes on average, mandatory 3 car garage, and approximately 17-20 units to be built per year
  - D. There will be a stone wall built and live oaks planted along Modica Lott and the developers plan to add a turn lane to get into the subdivision
  - E. There were lots of concerns about additional traffic congestion problems and Mr. Larkin did inform us that the city has already conducted a traffic study of the intersection of Swan Lake and Modica Lott and has determined that a traffic light is NOT needed at this time. He also told us about the future improvements to Swan Lake Road north of I-220:
    - 1. Phase I 2 lanes plus a neutral lane and a turn lane @ Modica Lott
    - 2. Phase II (if and when needed) 4 lanes and a neutral
